

## HOW DO I ADDRESS A CONCERN IN MY NEIGHBORHOOD?

If you are seeking relief from conditions on a property in your community, there are a number of options available to you.

Try making contact with the responsible person. Describe your concern, discuss how your concern affects you and/or the neighborhood, and consider possible solutions.


For issues relating to wildlife, rodents, insects, or dead birds, call Alameda County Vector Control at (510) 567-6800.

## WHO IS CODE ENFORCEMENT?

Code Enforcement is a division within the City's Community Development Department. The team spends the majority of their time responding to concerns that are located on private property. Their focus is to diminish public nuisances that affect health and life safety and enforce zoning rules. The team also focuses on the growing homelessness concerns in the community.

## WHAT ARE THE GOALS OF CODE ENFORCEMENT?

The team's main goal is to enhance the quality of life in Fremont's neighborhoods. By bringing code violations to the property owner's attention, homes and businesses are properly maintained, and the appearance and safety of the community is improved. Code Enforcement responds to several types of concerns including blighted properties, dangerous or unsafe buildings, residential auto repair, and unsafe or unsanitary homes. Through voluntary compliance and, if needed, citations and/or court orders, code violations can be eliminated or reduced. Working together with the community, Code Enforcement helps make Fremont a better place to live, work, and play!



## WHAT TYPES OF ISSUES DOES CODE ENFORCEMENT HANDLE?

### Blighted Properties:

Properties with an accumulation of garbage, old appliances/furniture, scrap metal, or fences with broken boards.



**Illegal Rentals:** An owner who illegally rents or leases a property.

**Dangerous or Unsafe Buildings:** Vacant buildings that are being accessed by unauthorized persons or a vacant building where the exterior is not being maintained.

**Homelessness Concerns:** Issues dealing with homelessness that negatively affect the health and life safety of the community.

**Illegal Construction:** Additions, alterations, sheds, patio covers, carports, and garage conversions constructed without a permit.

**Residential Auto Repair:** Major auto repair taking place in a residential zone. Minor homeowner auto repair is allowed if the vehicle is registered to the property owner.

**Unsafe or Unsanitary Homes:** Homes that are not in compliance with the minimum safety standards as set forth within the California Health and Safety Code.

**Weeds or Overgrown/Dry Vegetation:** Weeds or vegetation that poses a fire hazard or obstructs the public's right of way.



## WHAT ISSUES ARE HANDLED BY OTHER DEPARTMENTS OR AGENCIES?

**Homeowner Associations (HOAs):** Code Enforcement does not enforce HOA rules and regulations. Please refer to the HOA directly.

**Neighboring Fences:** Boundary fences sit on the boundary line between two properties. Both property owners are responsible for these fences.

**Neighboring Vegetation:** Vegetation that crosses the boundary line between two properties is the responsibility of the respective property owner.

### Trash Containers:

Issues with trash containers and residents leaving them in the street more than 24 hours before or after pick up are handled by Environmental Services at (510) 494-4570.



**Vehicle Abatement:** Issues with abandoned vehicles and/or illegally parked vehicles are handled by the Police Traffic Unit at (510) 790-6760.
