DISTRICT-BASED ELECTIONS / CONTENT OF DRAFT MAPS, SEQUENCE OF ELECTIONS – PUBLIC HEARING TO REVIEW DRAFT MAPS, SEQUENCE OF ELECTIONS, AND INTRODUCTION OF AN ORDINANCE OF THE CITY OF FREMONT TO TRANSITION FROM AT-LARGE TO DISTRICT-BASED ELECTIONS

Executive Summary: On March 21, 2017, the City adopted a resolution of intention to transition from at-large to district-based elections. Pursuant to Elections Code Section 10010, the City is required to hold five (5) public hearings within the time frames specified in the statute. At the May 2, 2017 public hearing, the Council decided to hold an additional hearing, which has been scheduled for June 13, 2017. The first four (4) public hearings are complete and allowed for the Council and community to weigh in on the composition of the districts and potential election sequencing. The June 6 hearing is the fifth required public hearing where the Council will make final recommendations to a preferred draft map and introduce an ordinance to establish district-based elections. At the sixth and final public hearing, the Council will vote to consider adoption of an ordinance establishing district-based elections.

BACKGROUND: The City Council held the first four (4) of six (6) public hearings on April 4, April 18, May 2, and May 16, 2017. The first three hearings allowed for the Council and community to comment on the composition of the districts and potential election sequencing. Draft voting district maps were published on April 25 and May 9, 2017, and presented and discussed at the third and fourth public hearings. Public comment and Council direction were provided regarding the content of the draft maps and the proposed sequence of elections. At the June 6 public hearing, the Council will make final recommendations and select a preferred district map and election sequencing and introduce an ordinance to establish district-based elections. At the sixth and final public hearing, the Council will vote to adopt an ordinance establishing district-based elections inclusive of the district map and election sequencing.

Public Outreach

Since adoption of the resolution of intent on March 21, 2017, the City has engaged in public outreach efforts to help inform the public about district-based elections and the process associated with their formation. A separate webpage to the City's website has been set up to provide information related to district-based elections including opportunities for when and how the public can contribute to the dialogue. In addition, the City has engaged its social media platforms to share information, and is taking input on the proposed draft maps and election sequencing from the community via Open City Hall. Posters and flyers including the draft maps and information on where to obtain more

details and provide input to Council have been distributed to and posted at all City facilities and at the Library. They have also been provided to the Fremont Unified School District. The City Council meeting agenda cover sheets and this staff report have been translated into seven languages to provide additional assistance to non-English speaking citizens. The languages include Spanish, Chinese, Vietnamese, Tagalog, Dari, Hindi, and Punjabi. The translated documents are available on the City's website at https://fremont.gov/districtelections. In addition, City Council meetings are *open captioned* for hearing impaired citizens in the Council Chambers and *closed captioned* for home viewing.

Drafting District Maps

Throughout the public hearing process, the City's consultant team has presented guidance on what factors should be taken into consideration when creating the new voting districts, including the following legally required criteria:

- Each council district shall contain a nearly equal population;
- A districting plan shall be drawn in a manner that complies with the Federal Voting
- Rights Act; and
- Each council district shall not be drawn with race as the predominate factor in violation of the principles established by the United State Supreme Court in Shaw v. Reno, 509 U.S. 630 (1993).

In addition, the demographic consultant, Lapkoff & Gobalet Demographic Research, Inc., has presented a variety of demographic and geographic data that served as potential criteria to define districts (in addition to the legal requirements). Based on all input from the City Council and the public at the first public hearing on April 18, the demographer divided the City into subareas and created a series of maps that were used by the public and Council to guide further discussions and to draft a variety of election district scenarios. The demographer also used highways, major roads, creeks, and railroads as (recognizable) boundaries, when possible.

Mapping Criteria

At the second public hearing, the Council directed the demographer to consider the following criteria in addition to the established legal requirements when preparing draft district maps. Please note that the criteria are listed without any particular priority:

- The City's 28 neighborhood districts
- FUSD elementary and high school attendance areas
- The City's 9 business districts
- Transit Oriented Development land-use designations
- Post 2010 housing and population growth
- California State Assembly district boundaries

- Congressional district boundaries
- Census blocks
- Geographic factors such as highways, major roads, creeks, and railroads as (recognizable) boundaries
- Cohesiveness, contiguity, integrity, and compactness of territory

Subsequently, at the third public hearing, the Council indicated its preference for Map C and requested the following additional criteria as a basis for revised draft maps.

- Proposed District 1 in the original Map C should be split so as not to combine areas in Ardenwood to the north and Bayside/Warm Springs to the south.
- To the extent possible, consider Fremont's established neighborhoods.
- To the extent possible, the consultants should analyze how to maintain as much of the Afghan community of interest in one district as possible
- Maintain compactness of districts ensure that boundaries follow clean lines and limit irregular shapes.
- Evaluate if the Glenmoor and Glen Manor neighborhoods can be placed in different districts to respect incumbency.
- To the extent possible, consider high school attendance areas.
- To the extent possible, ensure each district has a mix of uses, including both residential and commercial.

The City Council also instructed the demographer to apply the following preliminary considerations in assigning a potential sequence for elections within the districts of each draft plan for consideration of the public and the City Council:

1. Four districts shall be filled by election in 2018 as follows:

Two districts in which no incumbent resides (excepting the Mayor), shall be filled by election in 2018.

Any district in which an incumbent resides whose term expires in 2018, shall be filled by election in 2018 for a four-year term.

If the residences of current incumbents whose terms expire in 2018 are unavoidably paired in a district, that district shall, nevertheless, be filled by election in 2018 for a four-year term, and a third district in which no incumbent resides, shall be filled by election in 2018.

The City Council will then designate one of the districts in which no incumbent resides, for a two-year term. The other one or two districts will each have a four-year term.

2. Three districts shall be filled by election in 2020 as follows:

The two districts that were not filled by election in 2018, shall be filled by election in 2020 for four-year terms.

The district designated for a two-year term in 2018, shall be filled by election again in 2020 for a four-year term.

Number of Electoral Districts

The City Council directed the City's consultant team to devise draft maps based on a configuration of six (6) electoral districts with a Mayor chosen by the electorate citywide.

DISCUSSION/ANALYSIS:

Public Comments and Council Discussion

At the fourth public hearing on May 16, 2017, the community and Council had the opportunity to provide feedback on the four new draft maps that were prepared in response to Council's direction at the third public hearing. Those maps were titled, Map C-1, Map C-2, Map C-2a, and Map M. The City's independent legal consultant confirmed that all draft maps comply with the California Voting Rights Act and the Federal Voting Right Act.

The new maps removed the Bayside/Warm Springs area from District 1. Map C-1 kept the Glenmoor and Glen Manor neighborhoods together in District 3 while Map C-2 split the two neighborhoods so that Glenmoor was in District 2 and Glen Manor was in District 3. Map C-2a modified the boundary between Districts 2 and 3 in order to keep the majority of the Afghan community of interest in a single district. The demographers also prepared Map M to reflect the division of districts proposed by former Mayor Gus Morrison which was modified by the consultant team to comply with the California and Federal Voting Rights Act requirements.

Public comments regarding the draft maps were received both at the hearing and through the City's District Election website. A majority of public comment speakers expressed a preference for Map C-2a, which was a variation of Map C-2, originally posted on May 9th. Support for Map C-2a was primarily based on the fact that it maintains most of the Afghan community of interest in a single district. Additionally, members of the public suggested that Transit-Oriented Development (TOD) areas be represented in each district and that traditional neighborhoods be considered in district formation.

The Council, citing similar reasons, expressed preference for Maps C-1 and C-2a. Councilmember Jones suggested a slight modification to the boundaries where proposed Districts 4, 5, and 6 intersect to make districts a bit more compact and to divide the Irvington BART Station TOD more sensibly, assuming it would not substantially increase the population deviations of those districts. This modification has been made to both Map C-1 and C-2a and results in only a slight increase in the total deviation percentage for the plans. In addition to achieving greater compactness, the modified maps also divide the Irvington

TOD area between two council districts and place both sides of Osgood Rd. between Washington Blvd. and Durham Rd. in District 6. These updated maps were published on May 30th and are called Map C-1a and Map C-2b.

Election Sequencing

The City Council must also establish an election sequence schedule to ensure that there are six Councilmembers seated after the November 2018 election and that elections are staggered so that three Councilmembers are elected in each future election. Since there are currently two incumbents on the council with terms that don't expire until 2020 (Councilmembers Bacon and Salwan), this means that the remaining four seats must be filled by district elections in 2018. Under Map C-1a, one seat would be filled by an election in District 3 where two incumbents live and the other three seats would be filled by an election in three of the other four districts. Of those three seats, one would be a two year term so that there would be three district elections in 2020 (District 5 where incumbent Salwan lives and two others). Map C-2b is the same as Map C-1a except that there would be incumbents in both Districts 2 and 3 so only two of the remaining three districts would have elections.

The Council can select which open districts have elections by lot (drawing straws) or based on other criteria. For example, at the May 16, 2017 Council meeting, a member of the public suggested that District 1 should be selected because the City has not historically had any councilmembers from that area. The Council must also select which open district seat at the 2018 elections will have a two-year term. This can also be done by lot. An example of how the election sequencing could work is shown here. The shading shows how the District seat elections would be staggered.

Notes:

Map C-1a – Councilmembers Jones and/or Bonaccorsi would be running in District 3 in 2018. Since Councilmembers Salwan and Bacon would still be on the Council until 2020, three more districts would need to have elections in 2018 in order to have six Councilmembers seated after the November 2018 election. Council can choose any of the remaining four districts for the three remaining open seats. One of those seats would be for a two-year term so that elections can be staggered and three seats have elections in 2020 (Salwan's District 5 seat, the two year term seat and one more district). Councilmembers Salwan and Bacon would continue to represent the City "at large" until their terms expire in 2020.

Map C-2b –Councilmembers Jones and Bonaccorsi would be up for election in their Districts (2 and 3 respectively) in 2018. Since Councilmembers Salwan and Bacon would still be on the Council until 2020, two more districts would need to have elections in 2018 in order to have six Councilmembers seated after the November 2018 election. Council can choose any of the remaining three districts for the two remaining open seats. One of those seats will be for a two-year term so that elections can be staggered and three seats have elections in 2020 (Salwan's District 5 seat, the two year term seat and one more district). Councilmembers Salwan and Bacon would continue to represent the City "at large" until their terms expire in 2020.

Desired Outcomes

Pursuant to Elections Code Section 10010, this fifth public hearing is to introduce an ordinance identifying a preferred district map, establishing a sequence for future elections and identifying which terms will be two year terms and which will be four year terms. Draft ordinances are attached for both Map C-1a and Plan C-2b.

FISCAL IMPACT: There are no significant fiscal impacts associated with the holding of this public hearing.

ENVIRONMENTAL REVIEW: The proposed ordinance is exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the CEQA Guidelines in that there is no possibility that the ordinance will have a significant effect on the environment.

RECOMMENDATIONS:

- 1. Receive a report from staff concerning the process for obtaining public input on the draft maps of potential voting districts and potential election sequencing for a district-based election process pursuant to Elections Code Section 10010;
- 2. Open the public hearing and invite members of the public to provide feedback on the draft maps and potential election sequencing presented at the meeting;
- 3. Close the public hearing when there is no more input from the public and select a preferred draft map;
- 4. Find that the proposed ordinance is exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the CEQA Guidelines in that there is no possibility that the ordinance will have a significant effect on the environment; and
- 5. Introduce an ordinance establishing a district-based system of elections for City Councilmembers, establishing districts and the timing and sequencing of future elections.
