Project Description: The proposed project includes a General Plan Amendment to change the land use designation of a 1.9-acre site from Hillside Residential (<2.3 dwelling units per acre or <8.7 dwelling units per acre) to Low Density Residential (2.3 to 8.7 dwelling units per acre), Vesting Tentative Tract Map No. 8430 to subdivide the site into seven single-family residential lots ranging in size from 7,082 square feet to 13,920 square feet, a Variance to allow a reduction in street frontage for Lots 6 and 7 from 35 feet to 32 feet and 27 feet, respectively, and a Tree Removal Permit to remove a total of 26 trees from the site located on Morrison Canyon Road and at the end of Queso Place and Espada Place in the Mission San Jose Community Plan Area.
