Attending in person/Observe the meeting: The public will have the opportunity to attend in person or observe the meeting via [Live Stream](#) or view the Board Meeting via Fremont Comcast Cable, channel 26 (and 1084).

Provide public comment: Public comment will be accepted from those attending in person and from individuals participating remotely by phone during the live meeting.

1. In Person: Members of the public may attend a meeting in person.
 - To enter the building, please check in at the North Entrance (this is the entrance nearest to the Board Room).
 - Meetings are held at the District Office, 4210 Technology Drive CA 94538.
 - The district will default to its regular practice of community members completing the public speaking card which will be available on meeting day.

2. By phone:

 - To comment by phone, you will be prompted to "Raise Your Hand" by pressing "*9" to request to speak when Public Comment is being taken on the eligible Agenda Item.
 - When it is your turn to speak, the last four digits of your phone number will be called by the Administrative Assistant. You will then be unmuted, during your turn, and allowed to make public comments. After the allotted time, you will then be re-muted.

3. By Audio (*Zoom is only being used for audio public comments.*)
 - You may provide public comment by joining with an Internet connected device (tablet, computer, phone, etc.). Please note, this method serves as a one way communication. The public will be able to provide comments however, the public is unable to hear or have dialog with Trustees. You will need to view the meeting on a separate tab/browser or on cable TV.
