Of the 23.5 total acres, 6.75 acres would be re-designated Urban Residential, 15.25 acres would be re-designated Medium Density Residential, and 1.5 acres would be re-designated Public Facility. The proposed community would feature five separate villages, each containing a different type of housing product, including stacked and garden-style apartments that would be offered as rental units, and condominiums, townhomes and single-family cottages that would be offered for sale at market rate. Included in the 497 residential units would be 90 apartments that would be offered for rent to low, very low, and extremely low income senior households
