Mayor Mei opened consideration of Approval to Authorize the City Manager or Designee to Enter into Agreement and Issue Purchase Orders with ProPhoenix Corporation for the Software Installation, Professional Services, and Licenses for the City's Multi-Agency Law Enforcement CAD/RMS Software System in an Amount Not to Exceed \$2,126,006 and to Authorize Annual Support and Maintenance for a Ten Year Period in an Amount Not to Exceed \$2,036,061; to Enter into Agreement with Union City for their Share of the Costs for the New CAD/RMS Software System; and to Enter into Agreement and Issue Purchase Orders with Integration Partners in an Amount Not to Exceed \$502,960 (Purchase Replacement Software for the Police Department's Computer Aided Dispatch (CAD), Records and Management System (RMS) Software)

- Integration Partners in an amount not to exceed \$502,960 to provide integrations and professional services.
- 3. Authorized the City Manager, or her designee, to enter into a 10-year Maintenance Agreement and to execute any implementing documents and take any implementing actions as necessary with ProPhoenix Corporation, the amount of \$194,580 for the initial year of software support costs, will be waived at contract execution, and to renew the annual software Maintenance Agreement with ProPhoenix Corporation, with a 3% escalator or CPI, whichever is lower, for a total amount not to exceed \$2,036,061 over ten (10) years.
- 4. Authorized the City Manager, or her designee, to execute a CAD/RMS Software System Replacement Agreement with the City of Union City to replace the current CAD/RMS Software System in an amount not to exceed \$999,295.50.
- 5. If and when the City of Fremont receives the federal Grant discussed in the staff report, recognize the revenue in the Miscellaneous Federal Grants Fund (Fund 199) and appropriate it to the Police CAD/RMS Systems Replacement Project (PWC 9017-199).
