Hello,

My name is Justin and I am a Fremont Resident residing here in North Fremont (District 1), in the Ardenwood area, specifically the portion of Ardenwood near Karl Nordvik Park on Commerce Drive.

We have multiple different communities in our area, Capriana, California Vintage, California Meadows and Hampton Place. Ever since Karl Nordvik Park was changed from a Baseball Field to now a Soccer Field, our communities have seen an increased amount of cars parking in our neighborhoods taking up residential parking because there is not enough parking in the two small lots that Karl Nordvik Park has to offer.

I live in the California Vintage Community, and on behalf on multiple residents in our community, we have seen multiple cars being parked on Eucalyptus Terrace, which is **not public parking** but people who are attending soccer tournaments and practices are parking in front of peoples houses, where on one side of the street residents are allowed to park on, but on the other side, residents are not allowed to park on due to it being considered a "**fire lane**".

Due to the fact that one side of the street is not allowed for parking, we ourselves are faced with limited parking. What can the city do to help the parking situation at Karl Nordvik Park and our community? We are going to bring this issue up with our HOA as well to see if better signage about no public parking will help, but we also need assistance from the City.

*Residents from outside our community at California Vintage should not be parking in our community. Park users should not be coming into our community to park.*

### **Good evening, Fremont City Council,**

I am submitting a public comment for record tonight on behalf of California Mortgage Relief (<https://camortgagerelief.org/>), a new state-run program that can help homeowners stay in their homes and get caught up with their mortgage payments. The California Mortgage Relief Program is open to **all eligible Californians** and is **absolutely free**—funds never need to be paid back. Grants from the program are paid directly to your bank or mortgage servicer.

I am providing a link to the toolkit that you can share with your constituents (<https://camortgagerelief.org/partner-resources/>). Homeowners can visit [the program's webpage](#) to find out if they qualify, which is available in 6 languages.

Additionally, the program recently has expanded to include individuals who are behind on their property tax payments prior to May 2022.

If you have any questions, please do not hesitate to ask me!

### **In order to qualify for mortgage relief a homeowner must:**

- Only own and occupy one property;
- Be currently **behind on your mortgage payments**;
- Have missed **at least two mortgage payments prior to June 30, 2022**;
- Owe **\$80,000 or less** in past due mortgage payments;
- Meet household income requirements; AND
- Have experienced reduced income and/or increased living expenses due to the COVID-19 pandemic.
