- Data collection and analysis for the Paseo Padre Street Design project
- Mobility Commission advocacy for the safety improvements on Caltrans facilities within the City of Fremont

### **Public Comment:**

**Andreas Kadavanich**: Supports staff's recommendation for the road diet; expressed concerns about timeliness, would like to see it happen right away.

### 5. Discussion of 2022 Work Plan and Working Groups

Noe Veloso updated Commissioners on the work plan goals and accomplishments.

- June's meeting to be a workshop with Bike East Bay on best practices for community engagement and encouraging mode shift
- Reviewed accomplishments in the areas of Safe Routes to School and Communications
- Mode Shift work plan will continue with the development of an updated Active Transportation Master Plan and combine the previous pedestrian and bicycle master plans. The scope for the Active Transportation Master Plan will be agendized for a future Mobility Commission meeting.
- Staff received feedback from Commissioners on preferences to return to inperson Mobility Commission meetings or to remain with remote-virtual meetings.

### 6. Public Comment

**Gary Suplick:** Recommended the Mobility Commission agendize E-Bike rules and regulations and discuss possible changes to allow and encourage greater use.

**William Yargui:** Advocated for grant applications for other trail projects in addition to regional trails; supported more focused discussions on the City's TDM program.

**Steve Skala:** Asked staff to identify how other agencies are addressing opposition to bike infrastructure improvements; communicate and highlight signal improvements that will help driver experience

**Kelly Abreu:** Requests update of flow maps on City's website; supports wider sidewalks for the Centerville Completes Streets Project; requests updated trail signage on closed section of Morrison Canyon Road/Trail.
