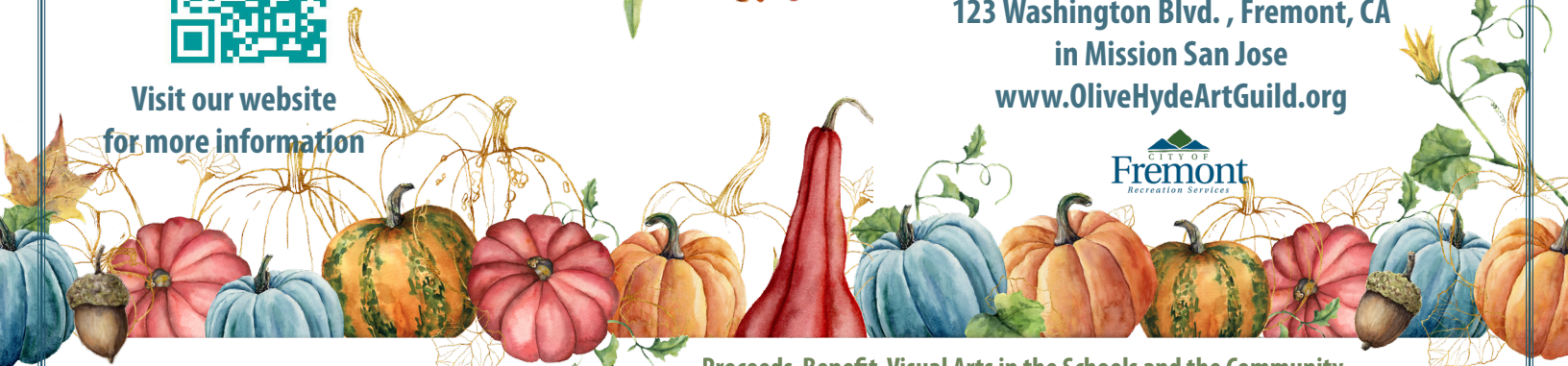

I've lived and worked in Fremont for over 30 years.
