## Petition

of Valdez Way residents to Fremont City Council

We are reporting the situation that has been unresolved for years: stray golf balls flying out of Fremont Park Golf Course and damaging property on Valdez Way.

The problems with stray golf balls started as soon as Fremont Park Golf Course was opened in 2005. The golf balls hit the neighborhood homes, broke windows, dented walls, broke roof tiles, and even landed on and damaged cars parked on Valdez Way. There is plenty of evidence to support this claim: multiple repair bills, balls collected in the backyards, and photos of damages. Some residents spent thousands of dollars from their own pockets to repair the damages caused by stray golf balls. There is a considerable risk of personal injury while one is in the backyard, and there is a profound risk that a damaged roof may go unnoticed and may cause water damage during the rain. The Golf course operators failed to respond to our concerns.

The City of Fremont Risk Management forced Fremont Park Golf Course to relocate tee #4, which reduced the frequency of stray balls, but did not eliminate them. We see that the only permanent solution to this problem is for Fremont Park Golf Course to install net screens on the golf course side facing Valdez Way. We ask the City of Fremont to act on behalf of Valdez Way residents and make the Golf Course install the safety nets.
