I have been a Fremont resident for over 15 years. As we celebrate Bike Month, I'm writing to relay my strong support of vision zero initiatives for safer biking, walking and driving in Fremont. Please fund and accelerate these vitality important initiatives.

I'd also like to let you know of my deep sadness in regards to the two recent fatalities on Blacow near JFK Highschool. These include the pedestrian that was struck and killed by a driver on December 02, 2022 and a motorcyclist that was killed by a speeding driver this past Friday April 28, 2022.

Sadly both of these fatalities might have been prevented with vision zero initiatives.

Personally I feel unsafe crossing Blacow at Palms, the site where a pedestrian was hit and killed by a driver December 02, 2022. I've talked to neighbors who have the same fear when crossing at this intersection. As many students cross Blacow going to JFK Highschool and the nearby parks and elementary schools I request that traffic calming be implemented for Blacow as soon as possible.
