Dear City Council,

Thank you for taking the time to read my email. I am a mom of two grown children and grandma of two grandkids that lives near the Stanford entrance of Mission Peak. I know you are in the midst of a difficult decision to balance the desires of two groups, which is always challenging. I wanted to share with you a little of my perspective, and I hope it can be helpful in even a small way.

Firstly, I deeply understand what a benefit to the city that Mission Peak has been. Over the years, many friends of my children have come to take on this nice hike, and I want to keep it accessible for others.

Secondly, I value the inclusivity of free public spaces such as hiking trails, parks, etc. I make use of them often, especially now that I have grandkids, and I think they are important for communities.

I share these points to show that my desire is NOT for people to no longer come through the Stanford entrance or for Mission Peak to be a private park for residents (which is often how I see the argument positioned).

My desire is that we can continue to make the Stanford entrance available to any who are interested without putting the welfare of residents at risk through unfettered parking situations.

My main issues with returning to free parking with no permits is a few things:

- Huge uptick in garbage on lawns, roads, etc.
- Increase in broken windows and other petty crimes.
- Frequency and multitude of speeding cars going down the road which puts the residents (especially children) at danger.

I want to make it clear that, if the MPC had shown a genuine understanding towards the needs of residents and a true ownership of what it would look like to address these concerns, I'd be much happier to consider their requests. However, what I've seen as a resident is that a return to permit-free parking will simply mean that residents will need to fend for themselves in these areas. I haven't heard any sense of responsibility that they would handle the increase in garbage, crime, and speeding in a concrete way, which is disappointing.

Some potential solutions I have are as follows:

- More promotion of the Ohlone entrance by the city through social media and other means. It's been evident that many don't know about this other entrance that has parking in abundance.
- A MPC/city-sponsored shuttle (potentially from Ohlone?) that can take hikers to the Stanford entrance if that's preferred. The Ohlone parking lot can be a "hub" for Mission Peak hikers to begin their day. It also leads to more promotion of our city's school (Ohlone College) and encourages hikers to simply walk across the street after returning from their hike to grab a meals thereby supporting local businesses.

Again, I hope you can understand that I greatly enjoy seeing people enjoy nature at Mission Peak! I also believe that residents in any given community shouldn't be penalized for not wanting their homes to feel like the parking lot of a national park. By keeping the parking situation as is, there is a balance of both needs - providing free public parking for hikers while protecting the needs of private homeowners.
