Ira Bletz provided a brief overview of the Ardenwood Historic Farm history and the new partnership with Dig Deep Farms. He presented the proposed improvements to the Dig Deep Farms farm corporation yard, which includes the construction of a steel barn and related infrastructure to facilitate the safe handling of organic produce grown at Ardenwood Historic Farm by Dig Deep Farms. The barn will include a cold storage facility, the workspace necessary for safe, clean, and healthy food production, and a storage unit. It will be located within the Farming Service Yard. The project complies with Ardenwood's Land Use Plan.
