REFUND POLICY

Refunds are allowed if requested up to seven calendar days prior to the start of the activity. A \$10 per class withdrawal fee will be deducted from your refund. Please allow up to four weeks for receipt of refund by check.

TRANSFER POLICY

Transfers are allowed up to seven calendar days prior to the start of the class. There is no charge for this service.

CANCELLATIONS

We reserve the right to cancel a class for any reasonable cause. Should this happen, your fee will be refunded in full or you may transfer to any open class.

NON-RESIDENT FEES

For persons not residing in Fremont, the fee is \$5 in addition to the published fee per class.

SENIOR CITIZEN DISCOUNT

Seniors (Ages 60+) receive a 10% discount on all classes except those designated for seniors.
