Centerville Complete Streets Project (City Project No. PWC8946, Federal Project No. CML-5322(060)) – The Project is located on Thornton Avenue between San Pedro Drive/Dondero Way and Fremont Boulevard; on Fremont Boulevard between Alder Avenue and Mattos Road; and Peralta Boulevard between Fremont Boulevard and Sequoia Road. The project will implement

complete streets upgrades and will also complete state of good repair improvements consisting of base repairs, curb and gutter replacement, sidewalk replacement, and AC overlay. The project is more specifically defined in the Contract Documents, but generally includes the following items of work: Furnish and maintain traffic control throughout the period of construction; maintain pedestrian barricades and detour pedestrian traffic around the work area; demolish and dispose of or recycle existing improvements including asphalt pavement, curb, gutter, sidewalk, curb access ramp, medians and traffic islands; construct protected intersection improvements, install new storm drain facilities, modify existing traffic signals to City standard equipment along with bicycle detection, pedestrian countdown heads, accessible push buttons and signal interconnection, install new signal at Thornton Avenue and Oak Street near Thornton Junior High School, remove right turn slip lanes, upgrade existing curb access ramp, install raised cycle track on Fremont Boulevard between Thornton Avenue and Peralta Boulevard, place hot mix asphalt concrete pavement, slurry seal pavement, install striping and pavement markings to narrow traveled lanes, install buffered bike lanes, install crosswalks and stripe green skip-striping through conflict zones. There may be other items of work not mentioned above that are shown on the plans and required by the State Standard Specifications and/or the Special Provisions. Engineer's estimate is \$9,500,000. The project consist of the clearing and grubbing of vegetation; demolition and removal of existing dirt and gravel pathway; rough and fine grading of site, storm drain installation with new area drains, field inlets and perforated subdrain systems; installation of sanitary sewer with sump and potable water line for drinking fountain; finished surfaces including 10' and 5' concrete pathways, 12" concrete curbs, 12" concrete retaining wall, poured in place safety surfacing, and synthetic turf; installation of exercise rig, isolated exercise equipment, shade structures, planting, including rock boulders, sod, and trees and site furnishings, such as benches, bike racks, trash and recycle receptacles and bollards; and provide connection to existing irrigation to support installation of new irrigation

Switchgear shall be a City furnished/contractor installed item. All underground utilities shall be brought to within 5 feet of the building envelope and shall include sewer, potable water, fire suppression, electrical and copper for communication for the two (2) new structures. New Restroom: The General Contractor shall be responsible for establishing all new utilities to within 5 feet of the new bathroom structure and preparing the structural pad for the prefabricated bathroom structure, to be set be the fabricator, The Public Restroom Company (PRC). The General Contractor shall provide access across the site for PRC to access the pad with their trucks and crane to offload and set the prefabricated structure. Concrete and Site Work: All earthwork and concrete associated with the bathroom foundation and access to the facility shall be the responsibility of the general contractor. Fire sprinklers within the prefabricated restroom shall be a deferred submittal and be the responsibility of the General Contractor. Engineer's Estimate is \$600,000. Occupancy is A-3. Interior mechanical work includes all plumbing, electrical, phone and computer cabling, air and heat ducting, heat pump and other related mechanical work. All utilities will be plumbed to 5 feet minimum outside the building envelope. Building shall be sprinklered. All fire sprinklers and fire alarm monitoring system shall be deferred submittals and shall be the responsibility of the building contractor and their

subcontractors. Exterior site work includes demolition of existing concrete, new concrete sidewalks around building, parking stall upgrades, self retention area and related landscaping. Fire service, potable service and electrical service will be installed to within 5 feet of the proposed structure under a separate contract.
