Currently, she is Counselor to the Family Caregiver Support program of City of Fremont, where she provides individual, couples, family and group therapy to family caregivers of the Tricity area. In addition to counseling, Frishta enjoys teaching Cognitive Aging and research on emotional memory. She has been part of Mills College Cognition laboratory in the past seven years. Her current research interest includes examining changes in emotional memory across different cultures and through the lifespan. Her research work has been published in Journal of Integrated Social Sciences, Journal of Psychology and Journal of Psychology and Behavioral Sciences.
