- 7. OLD BUSINESS
  - 7.1 WORLD HEALTH ORGANIZATION (WHO) AND AARP AGE-FRIENDLY ACTION PLAN UPDATE

**BACKGROUND:** The City of Fremont belongs to the World Health Organization's Age-Friendly Network. This worldwide network is organized into age-friendly domain areas, which in Fremont are: Health and Wellness, Outdoor Spaces and Buildings, Transportation, Social Participation and Inclusion, Volunteering and Civic Engagement, Community Information, Employment and Learning Opportunities, Housing and Dementia-related

Support. Information from the Fremont community in each domain area has been organized into an Age Friendly Action Plan.

The current draft of the Plan will be presented to the City Council during a Study Session on older adults to be held October 20, 2020 at 6:00 PM.

**RECOMMENDATION:** That the commission have the opportunity to hear an update on the Action Plan, the presentation to the City Council, and discuss the next steps.

#### 7.2 SENIOR CITIZENS COMMISSION CODE REVIEW –

Commissioner Yamasaki

**BACKGROUND:** The Senior Citizens Commission has been operating on long-standing processes, which have served the commission and the city well. With emerging efforts and challenges, such as the Age-Friendly Action Plan and the Covid -19 pandemic the commission has decided it may be time to review our mission and purpose.

At the June 25, 2020 meeting a work-group was appointed to create a mission statement for the Senior Citizens Commission. The workgroup consists of Commissioners Yamasaki, Hoyne, Yee and Young.

**RECOMMENDATION:** That the commission have the opportunity to hear an update on what this group has been working on.

That the workgroup has the opportunity to gather input from the Commission about next steps.

## **7.3 ACTION AREAS** – Chair – Commissioner Young

**BACKGROUND:** At the September 25, 2020 meeting it was discussed that the commission would still like to have a presence at the monthly Planning Commission meetings. It was suggested that the commissioners have a rotating schedule each month so that not one commissioner will always be attending the meetings.

**RECOMMENDATION:** That the commissioners decide how the rotating schedule will work and who will put that schedule together.

### 8. <u>NEW BUSINESS</u>

**8.1 Digital Inclusion** – Karen Grimsich, Administrator Aging and Family Services

**BACKGROUND:** The current pandemic has amplified how some older adults are isolated due to not being comfortable using digital devices to communicate. This has been called the Digital Divide. The Aging and Family Services division has begun to survey clients about what type of electronic device they use and how they use it.

**RECOMMENDATION:** That the commission hears a report on the current survey results and some plans to promote digital inclusion among our older adults.
