To address the Commission, a card must be submitted to the Chair indicating name, address and the number of the item upon which a person wishes to speak. Speakers are required to line up to conserve time between speakers. When addressing the Fremont Library Advisory Commission, please state your name and address. In order to ensure all persons have the opportunity to speak, a time limit may be set by the Chair for each speaker. In the interest of time, please limit your comments to new material; do not repeat what a prior speaker has said.



5.2 Vote for 2019 Commission Chair and Vice Chair

Finch motioned that Vivek be Chair and Sheen as Vice Chair. Commissioner Choe, 2nd. Aye: Commissioners Finch, Vivek, Liu, Lechner, Choe, Sheen.

5.3 A discussion of Municipal Code and Charge for Fremont Library Advisory Commission

Edwards distributed municipal code 2.20.360, 2.20.370, 2.20.380 for discussion, along with codes for communities in Pleasanton, Milpitas, San Ramon. The City of Fremont Municipal Code has three mains functions of the commission (section 2.20.380); library service for Fremont, development & construction of new facilities, and financing library services. The commission discussed operating hours and library facilities, which are separate functions. Tomorrow night is a City Council special work session on city facilities, and council will provide direction for city staff. The commission discussed the need for public outreach for the schools, community events, and the general public; Commissioner Lechner mentioned the "Speakers Bureau" presentation that a previous Fremont Library manager had distributed. Commissioners Vivek and Sheen would like to have a discussion at the next meeting, along with a list from Brian Edwards on talking points for the community.

5.4 Proposal to work with Art Review Board on existing monument on corner of Stevenson Blvd & Civic Center as a Library marquee

Edwards presented a request to transform the old marquee on the corner of Civic Center to a marquee for the Main Library. Edwards worked with prior City of Fremont Management Analyst Amanda Gallo to check with Community Development to make sure that it was not a historic piece. The monument was created for the old City Hall, which was demolished several years back. Commissioner Sheen & Commissioner Choe. Lechner motioned to create a subcommittee to modify the City owned monument, Sheen 2nd. Aye: Choe, Lechner, Liu, Finch, Vivek, Sheen.

6. STAFF REPORT

6.1. Brian Edwards, Principal Librarian

Brian presented a 2019 Library Facilities update document. Commissioner Vivek, Choe, and Sheen appreciated the upcoming facility changes.

6.2. Suzanne Wolf, City of Fremont

Suzanne talked about libraries & community centers and their importance as a 3rd space in the Community, along with the need for different models of education. Library Commissions can engage people about the use of space through their outreach and communication. Library, recreation, and other community spaces serve a purpose to intersect and to excite the community through age friendly programs and place design. Suzanne talked more about the Fremont & Library maker partnership, and the mindset to build, fail, and succeed together.

7. COMMISSION AND STAFF COMMUNICATIONS

7.1 Friends of the Library Report (Pat Finch)

Settling into new spaces at the Main Library. Had first sale in February, next sale in April. Hosting more lobby sales and 4 annual sales at the Main Library. Selling online now as well through the 'Book Forest.' Finch notes that it's an advantage to be onsite. Volunteers are

working more days per week since the space is smaller. Market to the students/teens how you can contribute to environment.
