 - 9.1 HRC Strategic Planning Retreat

BACKGROUND: On April 22, 2016, the Commission held a strategic planning retreat at the Dominican Sisters of Mission San Jose campus, using the following focus question to help guide the strategic planning process:

"What community needs/issues will the Commission address in 2016 and 2017 which will help support Fremont's diverse community and help sustain Fremont's social service safety net, prioritizing the HRC's strengths and opportunities?"

Staff is recommending the Commission review the 2016-18 strategic plan overview and results (enclosure 9.1.1) to evaluate whether or not the goals and timeline for accomplishing specific projects and actions, including 90 day implementation plans, are realistic and achievable. One measure of whether projects and actions are achievable could include the number of commissioners that sign up to be responsible for each project.

9.3 San Francisco LBGT Pride Parade and Resolution

BACKGROUND: On April 18, 2016, the HRC voted to once again spearhead the City's participation in the San Francisco LGBT Pride Parade. The next San Francisco Pride Parade is scheduled for Sunday, June 26, 2016, and will have the theme "For Racial and Economic Justice." Last year, the City's contingent included a 14 foot flatbed truck, which required extensive setup, decoration and coordination. Monitors are needed to attend trainings prior to the parade. Staff has submitted an application and paid the entrance fee based on a truck up to 20 feet. Chair Nguyen-Cleary agreed to take the lead on the parade.

On April 18, 2016, the HRC also recommended the City Council adopt a resolution declaring June as Pride Month in the City of Fremont and reaffirming its commitment to Lesbian, Gay, Bi-sexual, and Trans-gender equal rights. This resolution is scheduled to be read by the Mayor on Tuesday, June 7, 2016.
