Fremont residents blast 25 percent water rate hike proposal

Although it doesn't have the authority to do anything about it, the Fremont City Council on Tuesday allowed residents to tee off on hefty water rate and service charge increases proposed by the Alameda County Water District.

Staff added the proposed rates to the council's agenda after several residents expressed an interest in discussing them. Affected by the increases would be residents and businesses in Fremont, Newark and Union City.

The city of Fremont itself has been one of the district's biggest consumers of water. Over the last four years, it spent on average a little more than \$1 million a year on water.

The water district is proposing a two-year rate hike. In the first year, starting March 1, 2017, the fixed bimonthly service charge for most residential customers as well as the price per unit of water would both go up 25 percent.

The following year, again starting on March 1, both rates would climb an additional 5 percent each. One unit of water is about 748 gallons.

The district's five-member board is set to discuss the proposed hikes at its Feb. 9 public meeting.

About 50 people sent an email to the Fremont city clerk's office requesting the rate increase be discussed, with many of them writing to say they opposed the increases. About 25 people attended the meeting and four of them spoke against the rate increase during the public comment period.

Robert Shaver, the district's general manager, cited various reasons during the meeting why the increase is warranted.

He said the district faces a \$60 million revenue shortfall, largely because customers reduced water usage by roughly 30 percent during the drought.

The district's revenues are heavily tied to users purchasing water, but its labor and infrastructure costs are mostly fixed whether customers conserve or not, he added.

Councilman Raj Salwan said that as a consumer, he finds it hard to justify such a large rate increase in a short time frame.

Some members of the public, in person and in written statements, criticized the district for not cutting the salaries of employees, many of whom earn more than \$100,000, while raising rates.

But council members Vinnie Bacon and Rick Jones noted they recognize the need for paying competitive salaries to the district's workers.

Bacon emphasized that in Silicon Valley quality pay is necessary, and he rejected the argument that workers should simply take a pay cut to help the district fund its operations.

According to the district, the proposed service rate for the average residential customer would rise bimonthly from \$41.54 to \$51.92 after March 1, 2017. In the second year, that figure would increase to \$54.51. Every unit of water would increase from \$3.373 to \$4.216 in the first year, then to \$4.426 in the second year.

At the meeting Shaver said he understands the frustration in the community about raising the service charges.

"Because people feel like when the service charge is raised, they're not getting anything for that. But what the service charge partially funds are the costs to get water, from sometimes hundreds of miles away, to your home, at pressure, anytime you want to use it. And frankly, that's the vast majority of our operating costs, just to be able to do that," he said.

The water district will host a community meeting in Fremont on Jan. 23, from 6:30 to 8 p.m. at the Fremont Main Library in the Fukaya Meeting Room B, 2400 Stevenson Blvd., Fremont.

The Alameda County Water District board will consider the rate hike, as well as a potential program for assisting low-income ratepayers with their water bills, at a public meeting beginning 6 p.m. on Feb. 9, at 43885 S. Grimmer Blvd., in Fremont.

Letter Reaffirms City's Values of Being a Compassionate City

Fremont, Calif. – November 29, 2016 – The City of Fremont today released the following letter addressing the importance of diversity and maintaining safety and civility within the Fremont community:

November 28, 2016

An Open Letter to the Fremont Community:

The City of Fremont is one of the most diverse cities in the United States, and has been recognized as a national model of how people from different cultural, ethnic, and religious backgrounds can live and work together in peace and harmony. This is our City's greatest strength.

In recent conversations with many community members, we've heard several disturbing stories about hateful and terrifying exchanges as well as actions on our streets, in local businesses, and at schools and parks. Many community members have recounted in great detail how these interactions have left them feeling scared and fearful in their daily lives. Civility must continue to be our utmost priority, and there is no excuse to act disrespectfully toward certain members of our community because of the color of their skin, their religious beliefs, or their sexual orientation. We cannot and will not stand for this behavior in our community.

As a matter of official public policy, the City of Fremont has zero tolerance of prejudice, racism, bigotry, hatred, and violence. We strongly encourage anyone who has experienced an act of hate to report the incident immediately to the Fremont Police Department at 510-790-6800 option 3, or 9-1-1 if in immediate danger. We offer our assurance that all incidents will be thoroughly investigated and addressed. Additionally, we want to assure you that the City will be vigilant and vocal as it relates to any changes in federal policy that can impact this city we all call home.

Now more than ever, we must commit ourselves to the universal "golden rule," to treat others as you would like to be treated. As a Compassionate City that has adopted and signed a Compassionate City Charter on January 12, 2016, join us in making kindness and compassion a clear, luminous, and dynamic force in our polarized world.

We call on our Fremont community to continue the long tradition of tolerance and respect for people of all religious and cultural backgrounds, so that all Fremont residents feel accepted and safe in our community.



The City of Fremont Has Zero Tolerance for Hate Crimes

The City of Fremont is one of the most diverse cities in the U.S. and has been recognized as a national model of how people from different cultural, ethnic, and religious backgrounds can live and work together in peace and harmony. This is our City's greatest strength.

The City of Fremont has zero tolerance of prejudice, racism, bigotry, hatred, and violence, and is committed to maintaining peace and harmony in the community and ensuring all residents, regardless of their disability, nationality, race, ethnicity, religion, gender, or sexual orientation, enjoy the rights guaranteed by California law and the U.S. Constitution.

- Fremont places a high priority on investigating and resolving crimes involving racism and prejudice.
- Fremont works with institutions within the City, County, and Bay Area to foster greater education and understanding of the value of human diversity.

What is a Hate Crime?

A **hate crime** is a criminal act or attempted criminal act committed against a victim or their property because the victim is perceived to be a member of a protected class, including: disability, gender, nationality, race, ethnicity, religion, gender, or sexual orientation. Hate crimes can include:

- Physical assault
- Threatening phone calls
- Vandalizing personal property

The freedom of speech, as protected by the US Constitution, allows one to express opinions and ideas as long as it does not interfere with the civil rights of others. If this behavior escalates to threats being made or criminal acts being carried out, it could become classified as a hate crime.



What Should You Do If You Experience an Act of Hate?

The Fremont Police Department is committed to investigate all reported acts of hate and offers assurance that all incidents will be thoroughly investigated and addressed.

If you are in immediate danger and need to report an emergency, dial **9-1-1**.

To report a non-urgent matter or incident to the Fremont Police Department call: (510) 790-6800 and select option 3.

- Be prepared to speak with a dispatcher and/or police officer about what happened.
- Document the exact words spoken to you by the offender as soon as possible.
- Seek medical attention if you are injured.
