5.3 Review of 2019 Building Code Sustainability Opportunities (75 min)

BACKGROUND:

The California Building Code (Title 24 of California Code of Regulations) is updated in three year cycles. Local jurisdictions must adopt the California Building Code in its entirety as municipal code. Jurisdictions are prohibited from making local amendments to the code that would be *less* restrictive than the state code, but they can make revisions that are *more* restrictive so long as that jurisdiction finds that those amendments are reasonably necessary due to local climatic, topographical, or geological conditions, including environmental conditions established by the city or county.

The current code version is the 2016 California Building Code, and will be replaced with the 2019 Building Code effective January 1, 2020. The final version of the 2019 California Building Code is now available for local jurisdictions to review, amend, and adopt. In Fremont, the Building and Fire Departments will recommend the 2019 Building Code (with amendments and/or revisions) to City Council, with a first reading tentatively scheduled for late September or early October and a second reading to occur no later than November. Local amendments to the building code can be made at the time of adoption, or can be made at a later date through a city ordinance.

The City of Fremont may wish to consider measures go beyond the minimum standards found in the 2019 California Building Code by adopting "reach codes" as they relate to relevant sections of the building code. Of particular interest to the Commission are the Energy Code (Title 24, Part 6) and the Green Building Code (Title 24, Part 11).

In order for the Commission to further understand the opportunities available, staff will:

- 1) provide an overview of the requirements under the 2016 California Building Code, including energy and green building reach code measures adopted by the City of Fremont;
- 2) review the updated requirements under the upcoming 2019 California Building Code; and
- 3) highlight opportunities where the City may want to consider adopting reach codes.

Through this discussion, the Commission will discuss sustainability options under the 2019 California Building Code, prioritizing specific reach code opportunities that it would like staff to provide further analysis on. Based on these priorities, staff will then prepare the subsequent Commission meeting agenda with proposed options that the Commission could then vote on to make a formal recommendation to City Council.

Before any sustainability-related reach codes could be enforced, they must be filed with the Building Standards Commission (BSC) along with an adopted resolution finding that those measures are reasonably necessary due to local climatic, topographical, or geological conditions. Furthermore, reach codes specific to the Energy Code must also demonstrate "cost-effectiveness", i.e. that the lifetime cost of those measures are less than the anticipated lifetime savings. In order to determine cost-effectiveness, a study must accompany any proposed Energy Code amendments, and those amendments must additionally be reviewed by the California Energy Commission (CEC) prior to local implementation. The CEC review process includes a 15 to 60 day public comment period prior to bringing the item to its Board for approval. Only after Board approval can a local jurisdiction enforce Energy Code amendments.

Due to the timing of the Building Code adoption process, the Commission may wish to schedule a Special Meeting prior to the next Regular Meeting in December to make its formal recommendation to City Council. This would allow for any energy and green building recommendations made by the Commission to be considered by Council on a timeline as close to 2019 California Building Code adoption process as possible. Even with an expedited process, however, staff believes that given the complexity of the codes and the state requirements for adoption, any local amendments recommended by the Commission will not likely be enforceable until several months beyond the effective date of the new Building Code.
