1. Introduction

The meeting commenced with the introduction of those present.

2. Approval of Minutes

3. Dumbarton Quarry Park Update *

Landscape Architect Kim Fisher and Assistant General Manager of Operations Jim O'Connor provided an update on the Dumbarton Quarry Campground Project.

4. Mission Peak/Ohlone College Entrance Water Fountain Update

Park Supervisor Gordon Willey provided an update on Peak Trail Alternative Project (PTAP). New installations included cattle gate, water line and drinking fountain. The PTAP is intended to enhance the Ohlone College access to Mission Peak.

Item opened for public comment

Tony Pang, Fremont resident: Mr. Pang thanked staff for the water fountain installation at the Ohlone College entrance. He appreciated the EBPRD for not extending the park hours at Stanford Avenue staging area and was thankful for the weekend parking permit program.

Jannet Benz, Fremont resident: Ms. Benz thanked EBRPD for the new Peak Trail enhancement. Additionally, she suggested that the city considers public transit opportunities and bike racks installation at Ohlone College entrance.

William Yragui, Mission Peak Conservancy: Mr. Yragui thanked EBRPD for providing water fountain and restroom to the park visitors. He commented that new water line is installed above the ground and needs to be covered. He brought up the lighting issues at Mission Peak, Peak Trail.

Staff responded to Mr. Yragui's comments and clarified that the pipeline would be covered as the materials settle.

5. Dumpster Ramp Project Update - Ardenwood Historic Farm

Interpretive & Recreation Services Regional Manager Ira Bletz gave a presentation of the dumpster ramp construction. The dumpster ramp is permissible per the Land Use Plan Amendment for Ardenwood Historic Farm. The purpose of the ramp is an improvement for the health and safety of staff to dispose of garbage (non-recyclable materials) without risking injury.
