<u>William Yragui, Mission Peak Conservancy</u>: Mr. Yragui commented on making better connection of Alameda Creek Trail and other multi-use trails in the Fremont and surrounding cities. He also mentioned that the City should encourage access to the Vargas Plateau Park by restricting autos access on Morrison Canyon Rd. on weekends and consider the use of the 2.4 acres at Pickering.
