AGENDA SUMMARY

Dumbarton Quarry Park - Update

EBRPD will provide an update on the current status of construction with the extension of the sewer mainline into the campground and installation of other underground utilities.

Modification of EBRPD/City of Fremont Liaison Meeting Agreement

The current Memorandum of Understanding (MOU) between the East Bay Regional Park District and the City of Fremont outlines the terms and conditions of the Liaison Committee meetings. The MOU, created in 2003 after the dissolution of the former Ardenwood Park Advisory Committee, dictates the frequency and quantities of meetings to be held in a calendar year: a minimum of 3 times a year, with one meeting held in March/April. The Committee will discuss the possibility of amending the agreement to a minimum of two meetings annually with one held in the spring at Ardenwood and one in the fall.

Hay Storage Request for Ardenwood Pole Barn

EBRPD staff will propose the erection of a pole barn, which will be located east of the park office outside of the historic cove. The barn is permissible per the Land Use Plan Amendment for Ardenwood Farm. The pole barn will provide covered storage for hay grown at the farm and hay purchased on site. The pole barn will also reduce costs on hay deliveries, as well as lessen the potential for injuries from employees moving and stacking bales by hand.

Committee Member Dennis Waespi called the meeting to order at 6:01 p.m.

I. Introduction

The meeting commenced with the introduction of those present.

2. Approval of Minutes

By motion of Council Member Bacon and seconded by Committee Member Wieskamp, the minutes of November 10, 2016 were unanimously approved.

3. <u>Dumbarton Quarry Park Update</u>

Glenn Gilchrist, Design Manager provided a brief update on the progress of the campground phase. Jim O'Connor, AGM Operations provided an update on Phase II of the campground. Bob McCarrick and Adam Carvalho from Dumbarton Quarry Associates provided additional input regarding winds for Phase II and responded to questions from Committee Members.

Item opened for public comment.

Kelly Abreu, Fremont resident: Mr. Abreu commented on the differences between the original plan versus the current plan for the quarry. Item closed for public comment.

4. Mission Peak Parking Update

Kim Beranek, Recreation Superintendent provided an update on the parking program.

Item opened for public comment.

<u>Surinder Chowdhury, Fremont Resident:</u> Mr. Chowdhury commented that the new parking hours are working well and believe it would be a mistake to go back to the former hours.

Kelly Abreu, Fremont Resident: Mr. Abreu commented on the new parking hours, inquired on the painting of crosswalks and red curbs, commented on the parking tickets being issued for violations.

Melanie Wong, Fremont Resident: Ms. Wong expressed her appreciation to the City and the Park District for implementing the new parking hours and would like for them to remain as is.

William Yragui, Fremont Resident: Mr. Yragui informed he is speaking today on behalf of park visitors regarding park access, multi-use trails, extension of park hours and red painted curbs.

Randy Buswell, Fremont Resident: Mr. Buswell commented on the overall parking permit program and mentioned the number of cars and public walking the street has increased. He expressed his safety concerns for the neighborhood and suggested implemented a reservation system for public use.

<u>Colin Hsi, Fremont Resident</u>: Mr. Hsi expressed that he believes the neighborhood is a high crime area and has observed a vehicle on fire in the parking lot, has seen helicopters landing in the lot to provide emergency service to the public and requested to keep the current parking hours in place. *Item closed for public comment.*

Hans Larsen, Public Works Director responded to some of the issues raised by the public regarding signs and crosswalks.

5. Vargas Plateau Update

Terry Noonan, Interpretive Parklands Unit Manager, provided an update on the re-opening of the park, public usage, parking, access, and upcoming improvements.

Item opened for public comment.

Kelly Abreu, Fremont Resident: Mr. Abreu commented on the park closure, lawsuit, road side parking and water.

<u>William Yragui, Fremont Resident</u>: Mr. Yragui commented on the lower entrance to the park, the upper staging area and safety concerns of vehicles on the one lane road. *Item closed for public comment.*

6. Ardenwood Historic Farm Update

Ira Bletz, Southeast Regional Services Manager provided an update on recent and upcoming events, and programs offered at the park.

7. Public Comments

<u>Alice Chang, Fremont Resident</u>: Ms. Chang expressed her belief that the Mission Peak parking curfew violations are not being managed well and suggested building a high gate at the Stanford entrance to keep out violators.

<u>Tony Pang, Fremont Resident</u>: Mr. Pang commented on the revised Mission Peak park hours and stated he observes numerous cars in the parking lot after curfew hours, which impacts the residents.

Kelly Abreu, Fremont Resident: Mr. Abreu commented on the number of parking violations being issued in the parking lot of Mission Peak at Stanford Avenue.

Committee Member Dennis Waespi indicated a future meeting date and agenda items will be scheduled.
