AGENDA SUMMARY

Dumbarton Quarry Park - Update

Dumbarton Quarry and Associates (DQA) began site construction of the future campground and other parks facilities last year. The contractor completed connection to the existing Union Sanitary District sewer in Paseo Padre and installed the mainline in the maintenance roadway along the North of the site last fall. The site was closed in early winter due to heavy rains. Now that the site has dried out, sewer construction will continue after removal of a few old remnants from the quarry operation, such as a water valve, drain inlet, concrete pad and AT&T pole. Soil will then be placed to finish the subgrade in the future campground area. Upon completion of the sewer, the installation of storm and water systems will follow. DQA and the East Bay Regional Park District (District) have addressed City of Fremont final planning review comments and expect to submit plans for building permits by the end of the month. Construction of these facilities (phase one) is expected to be completed in the fall of 2018 with a planned opening of the park for public use in spring of 2019.

The District has been meeting with DQA representative to review a proposal to revise the existing phase two development plans. This revised plan would include a conversion of the planned meadow area to a mound resembling the historic ridgeline. This proposed plan revision will also provide expanded camping opportunities including convenience camping cabins and group campsites and additional restroom and shower facilities. This proposal is being reviewed by both parties, along with City staff, to determine any planning and permit requirements if the revised plans are approved by the District Board of Directors. In addition, the proposed changes will require a revision of the facility reclamation plan which requires City of Fremont approval.

Mission Peak Regional Preserve Parking - Update

City staff will provide an update on the permit parking program since the last Liaison meeting.

Vargas Plateau - Update

Staff will provide an update on changes that have occurred since re-opening to the public on May 15, 2017.

Ardenwood Historic Farm-Update

Staff will provide an update on changes in staff positions, recent and near future projects and special programs taking place at Ardenwood Historic Farm. A brief overview of concession operations, projects, and monarch habitat management will conclude the presentation.
