Mayor Mei opened consideration of a Public Hearing (Published Notice) to Introduce Ordinances Amending FMC Chapter 15.35 (Fire Code) to Require the Installation of Fire Sprinklers in Non-Residential Properties Undergoing Substantial Alterations and Amending FMC Chapter 15.44 (Energy Code) to Require the Installation of Photovoltaic Solar Energy Systems in New Residential Construction (2016 Energy & Fire Code Amendments)

The Affected Development Impact Fees Include: Capital Facilities, Fire Facilities, Park Facilities, Parkland, and Traffic (Development Impact Fee Annual Adjustment)
