Rancho Arroyo had an excellent safety record for 50 years. Now we see on-street pedestrians walking in the street where cars drift toward their curbside parking area -- dangerous! Now we see jaywalking. Fremont City Council prohibited on-street parking for over 45 years -- as a covenant -- destined to be litigated if parking continues to be allowed. Street parking is not needed on Rancho Arroyo. Apartment residents park on the street for convenience, not necessity. Why? Because Casa Arroyo parking lot spaces are tight and inconvenient. Curbside parking is easier. 600 parking spaces for 394 units (mostly one-bedroom and studio), the remaining are 2-bedroom, allows more parking spaces than many or most apartment buildings in the bay area. Several neighbors counted the number of empty parking spaces in the apartment parking lots after midnight on weekdays on several different nights. There were always many more EMPTY parking spaces in the apartment complex parking lot then the total number of cars parked on both sides of Rancho Arroyo. Even most of the Rock Ave parked cars would fit into the apartment parking lot. In other words, there were enough empty parking spaces in the apartment parking lots to accommodate all cars parked on Rancho Arroyo and almost all cars on Rock Avenue. This is a management problem of parking. We now see cars parked on Rancho Arroyo that are not being used -unmoved and un-used for weeks at a time. Here are the apartment parking lot counts on different nights after midnight: Empty parking spots in apartment parking lot: 74 Total number of cars parked on both sides of Rancho Arroyo: 52 Empty parking spots in apartment parking lot: 69 Total number of cars parked on both sides of Rancho Arroyo: 44 Empty parking spots in apartment parking lot: 75 Total number of cars parked on both sides of Rancho Arroyo: 44 Empty parking spots in apartment parking lot: 66 Total number of cars parked on both sides of Rancho Arroyo: 45 Empty parking spots in apartment parking lot: 56 Total number of cars parked on both sides of Rancho Arroyo: 41 Rancho Arroyo on-street parking is caused by at least four reasons: - Convenience (street parking is easier) - Excess cars not being used (cars not used for weeks, gathering debris, flat tires, covered with tarps...many people owning more cars than they use) - Tenant occupancy limits not enforced -- allowing apartment management to charge higher rents to be shared by larger numbers of people per unit - Lack of parking lot management. The apartment management needs an updated parking lot strategy rather than being managed like a more rural parking lot.

Rancho Arroyo Pkwy/Niles Blvd Intersection

Remove pylons for safety reasons. Add all-way stop signs to slow down traffic and protect pedestrians crossing both Niles Blvd and Rancho Arroyo.

Niles Boulevard

Retain two lanes in each direction (for safety reasons) to allow cars from cross streets to safely enter Niles Blvd. One lane in each direction would block cars from cross streets. Slow down traffic and protect pedestrians by adding all-way stop signs at two cross streets between Nursery Ave and the BART bridge (Rock Ave and Rancho Arroyo, possibly). Remove pylons that create confusion and erratic driving conditions. Niles Blvd does not need elimination of street lanes -- for safety reasons -- For example, Niles is land-locked, blocked on almost all sides by Alameda Creek and Quarry Lakes, and has very limited exits (4 exit streets) for emergency evacuation. An earthquake on the Hayward fault (a very likely possibility since the next earthquake is long overdue) could damage the BART bridge, the Sullivan bridge, and the train bridge at the south end of Niles Blvd. This scenario would leave Nursery Ave as the only exit for Niles residents ' but the train tracks that cross Nursery Avenue are directly over the highest-risk liquefaction zone along the Hayward fault. An earthquake and liquefaction could easily leave the train tracks buckled, bent, and cause Nursery Ave to be impassable. Such a scenario was discussed in the evacuation conference and the panel discussed the last ditch alternative for Niles residents to exit would be to bulldoze a route somewhere through Alameda Creek or the Quarry Lakes, which doesn't seem like a reasonable or timely way for Niles residents to evacuate in an emergency. Short of such a major emergency, Niles residents endure daily commute traffic congestion, causing significant delays just to exit the neighborhood. There's only one way out â€" Niles Blvd!

Other Comments or Recommendations

Regarding parking along Rancho Arroyo. Each night, there are over 70 EMPTY parking spaces in the apartment parking lot and about 26 cars parked on Rancho Arroyo along the apartments. Why overturn 45 years of Fremont city council decisions that prohibited street parking to allow only 26 cars parked on Rancho Arroyo (when 75 empty spaces exist in the parking lot)? Apartments around the country manage their parking through permits, fees, or credits. Here's an interesting article for anyone interested in urban planning and the trend toward less reliance on multiple cars for everyone (I used to own three cars; now I have one). "NAA: Multifamily parking ratios lowest since 1960s" https://www.housingwire.com/articles/46476-naa-multifamily-parking-ratios-lowest-since-1960s "Impending autonomous cars, ride-sharing, affordability, legislation are pushing parking ratios down" "Parking ratios for multifamily properties are falling in most metros thanks to urbanization and changing attitudes toward car ownership." "According to a study from the National Apartment Association, over the last decade, the average parking ratio per unit dropped to 1.46, the lowest it has been since the 1960s." Casa Arroyo has 600 parking spacers for 394 mostly studio and 1-bedroom units. Some 2-bedrooms. No 3-bedrooms. this is more than enough parking spaces in the lot. Please allow the Hacienda Gardens neighborhood to have residential parking permits.

Road revisions should be prioritized for safety AND what is BEST FOR ALL. There are plenty of dangerous potholes throughout the city and repairs have been lax. On Country Drive confusing sticks have been put up at Pedestrian crosswalks but the potholes all the cars swerve around (and can hit other cars, plus lead to dangerous momentary blindness episodes from water splashes in the rain on windshields.) The sticks have done nothing for Pedestrian safety but have produced road hazards for drivers. Mowry has potholes and it's a high traffic road. I see Paseo Padre Parkway being re-lined but with no fixes to the actual roadway surface. Not fixing the roads and focusing on signs for Pedestrian crossings does not make sense, nor helps. The signs are just sticks in the road now and make for confusion at night if there is an object off to the side or not. Parking is a HUGE problem on Rancho Arroyo Parkway and just yesterday I counted all cars parked on Rancho Arroyo on The Trees side could fit on street parking in the cul de sacs and all cars on the apartment side of both Rancho Arroyo and Rock Avenue could fit within the confines of the apartments, clearly showing people are parking on the street because they want to, not because there isn't space where they live. Establishing clear cut rules so problems don't become problems is essential. As a resident of the Rancho Arroyo area I have indeed enjoyed two lanes in each direction, but I understand conditions have changed.I was surprised to see that each unit in Casa Arroyo had been assigned only one spot, but that approval was long ago and obviously based on conditions existing at that time. It is what it is. The property owners should be applauded for their successful efforts to maintain an extremely nice facility. The unsightly and cumbersome poles at the Rancho Arroyo Parkway/ Niles Boulevard intersection do make the crossing safer. To be blunt, the City has no choice but to leave the poles intact unless bold solutions are considered. Absolutely nobody even has responded to what I believe is a logical and practical solution. First of all, extend the sidewalk along the west side/north side of Rancho Arroyo at least to the intersection of Rancho Arroyo and DeVille, a very short block away. Then eliminate the crosswalk as it now exists at the corner of Niles Boulevard and Rancho Arroyo. Almost nobody crosses here anyway. It would be a very minor inconvenience to simply walk the very short block and cross at DeVille. I suggest a 4th option which I believe will be a good compromise and be a safer option. Retain the current design on the north side of Rancho Arroyo with parking and buffered bike Lane. On the South side remove the parking and return the road to 2 lanes with a smaller buffered bike lane (in the current parking area.) This will provide parking for the apartments, buffered bike lanes and 2 lanes of traffic that will provide for any emergency evacuation of the area if there was a fire in a community with abundance of trees and limited exit routes for the neighborhood.

Option 1: I could live with Option 1 if the following was taken into consideration: returned the right hand turn lane that is now blocked with poles but retain the caution markings for the bikes and eliminated the current right hand turn lane and used that space to create both a wider left hand turn lane and wider lane for entering Rancho Arroyo from Niles Blvd. Option 2. The concrete curb in option 3 does not address the issues of the current design which resulted in difficult right turns from Rancho Arroyo onto Niles Blvd. To make the turn we currently have to turn into the inside lane of Niles Blvd which puts ourselves and cars at risk of being hit by traffic heading south on Niles Blvd.

Do not add parking to Niles Blvd. Any parking will restrict vision of traffic on Niles Blvd for those entering from the side streets.
