- 3. Found, on a separate and independent basis, that no further environmental review is required for the project pursuant to the California Environmental Quality Act (CEQA) Guidelines Sections 15162 and 15183, as the project is consistent with the General Plan/Zoning and the project analyzed in the approved Mitigated Negative Declaration Prepared For the Warm Springs BART West Access Bridge and Plaza Project; Section 15061(b)(3), as it can be seen with certainty that there is no possibility that the project will have a significant effect on the environment; and Section 15378(b)(2), (4)-(5), as this is an administrative activity.
