- 7. OTHER BUSINESS
 - A. Mayor Mei opened consideration of Approval to Authorize Staff to Partner with Shangri-La Industries, LLC and Step Up On Second Street, Inc. on an Application for Funding Under the State Homekey Round 2 Program to Acquire, Rehabilitate and Operate a Supportive Services Affordable Housing Project at 46101 Research Avenue (Currently the Motel 6) (Application for State Homekey Round 2 Funding)

Email submitted to the City Clerk were compiled, distributed to the City Council and staff, and published in the City's Agenda Center on fremont.gov, and were placed on file.

Community Development Director Dan Schoenholz and Human Services Director Suzanne Shenfil provided a presentation and responded to questions from Councilmembers. Mayor Mei opened the public comment period. The following persons spoke in support of the project: Robert Daulton, Marie Hughes, Jane Lin, Lisa Danz, Sandra Moore, Hayes Shair, Katherine Rubie, Blair Beekman, Darlene Crittendon, Vinita Verma, and Annie Koruga. There being no

additional speakers, Mayor Mei closed the public comment period. This was followed by another question and answer period between Councilmembers and staff. Councilmembers provided comment.

On a motion by Councilmember Jones, seconded by Councilmember Cox, the City Council:

- 1. Adopted Resolution No. 2022-04 authorizing the submittal of a Homekey Round 2 application to the California Department of Housing and Community Development (HCD), with the City as the lead applicant and Shangri La Industries and Step Up as coapplicants, in the amount not to exceed \$40,200,000 and making findings of CEQA exemption.
- 2. Approved a funding commitment and allocation for a Homekey Project in the City of Fremont to be acquired, rehabilitated and owned by Shangri La Industries, in the amount not to exceed \$6,738,805 from the City's Affordable Housing Fund (Fund 196); and \$2,590,000 from the secured funding sources, including \$750,000 in CDBG funds, \$1.25 million in LMI funds, \$400,000 in PLHA funds and \$190,000 in CARES Act funding as described in the report.
- 3. Authorized the City Manager or her designee to execute a MOU with Shangri-La Industries and Step Up on Second Street, Inc., memorializing roles and responsibilities.
- 4. Authorized the City Manager or her designee to execute agreement(s) and/or implementing documents with Shangri La Industries and Step Up on Second Street, Inc. to effectuate the implementation of a Homekey project in the City of Fremont.
- 5. Authorized the City Manager or her designee to execute a funding agreement and other implementing documents with the State of California Department of Housing and Community Development.
